- Carrying out the necessary processes by our business units to execute Setur Marinas' commercial activities and to carry out the corresponding business procedures,
- Ensuring Setur Marinas' employees' or business partners' legal, technical, and commercial-occupational security,
- Developing and executing Setur Marinas' commercial and business strategies,
- · Carrying out legal processes,
- · Carrying out information technologies processes,
- · Management of audits and ethics activities,
- · Planning and execution of customer satisfaction and corporate communication initiatives,
- Organizing draws, campaigns, competitions, promotions, or other forms of advertising,
- Retention of personal data for the duration of the general statute of limitations so that it can be used as evidence in possible future conflicts,
- · Receiving, assessing, and resolving your requests and complaints,
- If you have given your explicit consent, your identity, communication, customer transaction, and

### Recipient Parties and Purposes for Transferring Personal Data

Your personal data collected for the above-mentioned Purposes may be transferred to our business partners, suppliers, and legally authorized public institutions and legally authorized private persons in case it is expressly stipulated in the laws and for fulfillment of our legal obligations, in accordance with the rules regarding the transfer of personal data specified in Article 8 of the Law and within the framework of the personal data processing conditions specified in Article 5 of the Law.

### Method and Legal Grounds for the Collection of Personal Data

Your personal data may be collected by and via filling out online participation forms/contact forms/application forms, call center, mobile applications, text messages, e-mails in the electronically and via meetings with Setur Marinas in person and forms physically.

Your personal data may be collected and processed by Setur Marinas for the following purposes and legal grounds, based on the personal data processing conditions specified in Article 5 of the Law.

Based on the legal ground that processing of personal data of the parties of a contract is necessary, provided that it is directly related to the establishment or performance of the contract;

- Updating and verifying the customer information,
- Management of sales records and billing operations,
- Due to your purchase of Setur Marinas' products and services, the establishment or execution
  of sales or service contracts,
- Providing assistance to customers.

Based on the legal ground that it is expressly provided by the laws and necessity for the fulfillment of the legal obligation to which the data controller is subject to;

- Responding to demands from official authorities,
- Informing the authorized agencies due to the legislative obligations,
- Ensuring that the storage requirements outlined in the Act are met.
- Conducting the evaluations of the applications you convey to the Company, based on exercising
  your rights stipulated in Article 11 of the Law regarding your personal data that are processed
  by our Company, finalizing these applications according to the legislations and conducting the
  necessary processes in this regard.

Based on the legal ground of data processing being mandatory for the legitimate interests of the data controller, provided that this processing does not violate the fundamental rights and freedoms of the data subject:

### Based on your explicit consent;

- Your identity and contact information may be processed for sending commercial electronic messages such as advertisements, promotions and campaigns.

### Data Subject's Rights Specified under the Article 11 of the Law

In relation to your personal data, you are entitled to the following rights, set forth under Article 11 of the Law:

- · To learn whether your personal data are being processed,
- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,
- To request rectification in case your personal data has been processed incompletely or inaccurately and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To demand the erasure or destruction of your personal data in the event that the reasons for the processing no longer exist even though it was processed in accordance with the Law and other relevant provisions and to demand the operations in this regard be reported to third parties your personal data has been transferred to,
- To object to negative consequences to you that are concluded, as a result of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered as a result of unlawful processing of your personal data.

You may convey your requests concerning your rights listed above to our Company, by filling out the Data Subject Application Form, which can be found at. Depending on the nature of your request, your application will be concluded, as soon as possible, within 30 days at the latest, and in principle, free of charge. However, if the process requires additional costs, a fee may be demanded according to the tariff determined by the Personal Data Protection Board.
